Training Agreement – Cuddle Therapy Training



between

– hereinafter referred to as the "Provider" –

and the person submitting the application

– hereinafter referred to as the „Participant" –

1. Subject of the Agreement

The Provider offers a Cuddle Therapy Training program.

The purpose of the training is to enable the Participant to:

- offer professional one-to-one **Cuddle Therapy** sessions independently; and/or
- apply the methods learned within related professional fields.

The implementation of the training content and the Participant's individual professional path remain their own responsibility.

Completion of the training does **not** create any entitlement to become a member of the **KuschelRaum Network**.

2. Scope of the Training

The **Cuddle Therapy Training** provides professional knowledge, practical skills, and personal development in the fields of mindful touch and professional client support. The program is modular in structure and combines in-person training with self-study.

- The training includes, in particular:
- Theoretical and practical instruction.
- Personal development and reflective learning.
- Digital learning materials (including pre-recorded videos with English subtitles and PDF resources).
- Printed training materials (including the training manual).
- Supervision. (The training includes a total of three hours of individual supervision, which must be used within two years of the training start date.)

3. Certification

The aim of the training is to qualify for certification as a **KuschelRaum Certified Cuddle Therapist**. Certification is granted only after the Participant has successfully completed the entire training program, including all required practical and reflective components.

This includes the completion of **ten documented cuddle therapy sessions** following the in-person training modules. These sessions must be documented and reflected upon as part of the training. Discussion of these practice sessions forms an integral part of the supervision process.

The decision to award certification is based on the Participant's performance throughout the training, including observations during the in-person modules, practical reflections, and the supervision sessions.

There is **no automatic entitlement** to receive certification. This also applies if all training materials have been provided and/or the full tuition fee has been paid.

4. Registration

Registration for the **Cuddle Therapy Training** is binding.

Upon submission of the registration form, a registration deposit of EUR 300.00 becomes payable. This deposit forms part of the total tuition fee and is credited in full toward the overall cost of the training.

5. Tuition Fees

The Participant's obligation to pay the tuition fee, including the amount, due dates, and selected payment method, is governed by the binding registration form.

The tuition fee is payable regardless of whether certification is ultimately granted.

In all other respects, the payment terms set out in the Terms & Conditions shall apply.

6. Withdrawal, Cancellation, and Transfer of Registration

For the purposes of this Agreement, the training start date is the first official training date specified in the registration form.

Withdrawal Before Digital Content and Training Materials Have Been Provided

- If the Participant withdraws from or cancels the Training Agreement before any digital content (e.g. videos or PDFs) and/or training materials (e.g. the training manual) have been made available, the following provisions apply:
- Up to eight weeks before the training begins: The Provider is entitled only to the EUR 300.00 registration deposit.
- Less than eight weeks, but at least four weeks before the training begins: 50% of the total tuition fee becomes payable.
- Less than four weeks before the training begins, or in the event of non-attendance (no-show): 100% of the tuition fee is payable.

Withdrawal After Digital Content and/or Training Materials Have Been Provided

Once digital content (such as videos or PDFs) and/or training materials (such as the training manual) have been made available to the Participant, these materials constitute an essential part of the training.

From that point onward, at least 80% of the total tuition fee remains payable, regardless of when the Participant withdraws from or cancels the Training Agreement.

If the Participant withdraws within four weeks of the training start date or after the training has begun, 100% of the tuition fee is payable.

Transfer of Registration

A registration may be transferred to a substitute participant with the Provider's prior approval. There is no automatic entitlement to transfer a registration. Any transfer must be made in writing and becomes effective only after written confirmation by the Provider.

Written Form

Any withdrawal or cancellation must be submitted in writing.

Repeating or Catching Up on the Training

Participants may, subject to prior agreement with the Provider, repeat or make up the **Cuddle Therapy Training**. The fee for repeating or catching up on the training is 50% of the regular tuition fee applicable at the time of participation. There is no entitlement to repeat or make up the training at a particular time or within a particular training cohort.

7. Final Provisions

Any amendments or additions to this Agreement must be made in writing. This also applies to any amendment or waiver of this written-form requirement.

Should any provision of this Agreement be or become wholly or partially invalid or unenforceable, the validity of the remaining provisions shall remain unaffected. In place of the invalid or unenforceable provision, a valid provision shall apply that most closely reflects the economic purpose of the original provision.

Terms & Conditions (T&Cs)

KuschelRaum – Bewusst berühren

1. Formation of the Agreement

The Training Agreement is concluded when the Participant submits a binding registration and the Provider confirms the registration. The registration is binding.

2. Conclusion of Contract

The contract is concluded upon the binding registration of the participating person and confirmation by the provider. Registration is binding.

3. Payment Terms

Tuition fees are payable after the Participant has received an invoice. All payment deadlines are binding. Failure to pay the tuition fee does not constitute a cancellation of the registration. In the event of late payment, the Provider reserves the right to charge reminder fees and to take any further legal action available.

4. Cancellation or Changes by the Provider

If the training cannot take place for reasons for which the Provider is responsible, any payments already made will be refunded in full. No further claims may be made against the Provider. If the training cannot be conducted as planned due to force majeure or other circumstances beyond the Provider's reasonable control, the Provider reserves the right to cancel, postpone, or make reasonable changes to the training. If the training is cancelled in its entirety or substantially altered, the Participant has the right to withdraw from the Training Agreement. In this case, any payments already made will be refunded in full. No further claims may be made against the Provider. The Provider also reserves the right to make reasonable changes to the training content, schedule, or individual program elements, provided that the overall character and objectives of the training remain unchanged. Such changes do not give rise to a right of withdrawal.

5. Use of Training Content and Materials

All content, training materials, and digital or printed resources provided as part of the Cuddle Therapy Training are intended solely for the Participant's personal use.

The Participant is responsible for the independent and appropriate application of the knowledge and skills acquired during the training within their own professional or personal practice. Without the Provider's prior written consent, the Participant may not use the training materials or substantial parts of the training for teaching, training, or educating third parties.

Likewise, the reproduction, distribution, publication, translation, sharing, or any other commercial use of the training materials or their contents—whether in whole or in part—is strictly prohibited without the Provider's prior written permission. The automated analysis of this work for the purpose of extracting information—particularly patterns, trends, or correlations—within the meaning of Section 44b of the German Copyright Act (UrhG) ("text and data mining") is prohibited.

6. Right of Withdrawal for Digital Content

The Participant's right of withdrawal with respect to digital content (such as videos and PDF materials) expires, to the extent permitted by applicable law, once performance of the Training Agreement has begun and the Participant has expressly consented in advance to the provision of such digital content.

7. Confidentiality and Recordings

All personal information, experiences, and processes shared by Participants and other persons present during the training are strictly confidential.

The Provider will only take photographs or video recordings with the express consent of the persons concerned.

Participants are not permitted to make audio recordings, video recordings, or photographs during the training without the Provider's prior written permission.

Such consent is entirely voluntary and may be withdrawn at any time with future effect.

8. Liability

The Provider's liability is limited to the extent permitted by applicable law.

To the extent legally permissible, the Provider shall not be liable for indirect or consequential damages, loss of profit, loss of earnings, or any other financial losses.

The Provider accepts no liability for personal belongings brought to the training.

The knowledge, methods, exercises, and recommendations taught during the training are applied entirely at the Participant's own responsibility. The Provider accepts no liability for any damages arising from the application, interpretation, or sharing of the training content.

The Cuddle Therapy Training is intended for educational purposes only. It is not designed to diagnose, treat, or cure medical or psychological conditions and does not replace medical, psychological, psychotherapeutic, or other healthcare treatment. If appropriate, it is the Participant's responsibility to seek qualified medical or therapeutic support.

9. Personal Responsibility and Scope of the Training

The Cuddle Therapy Training is designed to support both professional development and personal growth. It does not constitute psychotherapy, medical treatment, or any other form of healthcare, nor does it replace such services.

Participation is entirely voluntary and at the Participant's own responsibility. Each Participant decides for themselves to what extent they wish to engage in practical exercises, experiential processes, and other training activities.

If the Participant has an existing physical or mental health condition, or any other circumstance that may affect participation, it is their responsibility to determine—preferably in consultation with an appropriately qualified healthcare professional—whether participation in the training is suitable. The Participant also agrees to inform the Provider before the training begins of any existing circumstances, previous experiences, or limitations that could significantly affect their participation in the training or in specific training activities.

10. Data Protection

The Provider processes the Participant's personal data in accordance with the applicable data protection laws.

Personal data collected during the registration and training process will be used solely for internal purposes, including the administration of the Training Agreement, organization of the training, accounting, quality assurance, and the Provider's own information and marketing activities (such as newsletters).

Personal data will not be disclosed to third parties unless required by law or by a lawful order of a public authority.

The Provider takes appropriate technical and organizational measures to protect personal data in accordance with current industry standards. To the extent permitted by applicable law, the Provider accepts no liability for damages resulting from malicious cyberattacks or other security breaches that could not reasonably have been prevented.

11. Final Provisions

Should any provision of these Terms & Conditions be or become wholly or partially invalid or unenforceable, the validity of the remaining provisions shall remain unaffected.

These Terms & Conditions shall be governed by the laws of the Federal Republic of Germany.

To the extent permitted by applicable law, the place of jurisdiction shall be the Provider's registered place of business.
